

Part VI: Summary of the risk management plan

Summary of risk management plan for Levosimendan STADA 2,5 mg/ml concentrate for solution for infusion (Levosimendan)

This is a summary of the risk management plan (RMP) for Levosimendan STADA. The RMP details important risks of Levosimendan STADA, how these risks can be minimised, and how more information will be obtained about Levosimendan STADA's risks and uncertainties (missing information).

Levosimendan STADA's summary of product characteristics (SmPC) and its package leaflet give essential information to healthcare professionals and patients on how Levosimendan STADA should be used.

I. The medicine and what it is used for

Levosimendan STADA is authorised in adults for the short-term treatment of acutely decompensated severe chronic heart failure (ADHF) in situations where conventional therapy is not sufficient, and in cases where inotropic support is considered appropriate (see SmPC for the full indication). It contains levosimendan as the active substance and it is given intravenously.

II. Risks associated with the medicine and activities to minimise or further characterise the risks

Important risks of Levosimendan STADA, together with measures to minimise such risks and the proposed studies for learning more about Levosimendan STADA's risks, are outlined below.

Measures to minimise the risks identified for medicinal products can be:

- Specific information, such as warnings, precautions, and advice on correct use, in the package leaflet and SmPC addressed to patients and healthcare professionals;
- Important advice on the medicine's packaging;
- The authorised pack size — the amount of medicine in a pack is chosen so to ensure that the medicine is used correctly;
- The medicine's legal status — the way a medicine is supplied to the patient (e.g. with or without prescription) can help to minimise its risks.

Together, these measures constitute *routine risk minimisation* measures.

If important information that may affect the safe use of Levosimendan STADA is not yet available, it is listed under 'missing information' below.

II.A List of important risks and missing information

Important risks of Levosimendan STADA are risks that need special risk management activities to further investigate or minimise the risk, so that the medicinal product can be safely administered. Important risks can be regarded as identified or potential. Identified risks are concerns for which there is sufficient proof of a link with the use of Levosimendan STADA. Potential risks are concerns for which an association with the use of this medicine is possible based on available data, but this association has not been established yet and needs further evaluation. Missing information refers to information on the safety of the medicinal product that is currently missing and needs to be collected (e.g. on the long-term use of the medicine);
